Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

Proposed Work and Purpose: Miami-Dade County Schools repaired windows, curbs, interior lighting, fencing, signage,

flooring, molding, ceilings, interior walls, exterior walls, marquee signs, playground equipment, exterior lighting, fire protection devices, and building contents at four schools in the district as a result of Hurricane Irma. The school board confirmed that the facilities are protected against flooding by design and flood hazard minimization measures are not

required at this time.

Project Alternatives: FEMA has considered the no-action alternative and has determined that taking no action

would not be a feasible alternative to repairing the schools. Other building locations were not considered, as these facilities were not substantially damaged and relocation would

not be practicable.
